THE BUSINESS DEVELOPMENT PROGRAM AT THE MISSOULA ECONOMIC PARTNERSHIP (MEP) IS DESIGNED TO CATER TO BUSINESSES AT ALL STAGES, OFFERING DIRECT SERVICES AND COLLABORATING WITH KEY PARTNERS. IN 2023, MEP CONDUCTED 52 BUSINESS RETENTION VISITS WITH MISSOULA COUNTY BUSINESSES, MARKING A SIGNIFICANT INCREASE FROM THE PREVIOUS FISCAL YEAR. THESE VISITS WERE AIMED AT UNDERSTANDING BUSINESS PRIORITIES, EXPLORING AVAILABLE RESOURCES, AND GAINING INSIGHTS INTO THE CURRENT BUSINESS CLIMATE. THROUGH THESE ENGAGEMENTS, MEP NOT ONLY FOSTERED STRONGER RELATIONSHIPS WITH LOCAL BUSINESSES BUT ALSO GAINED A DEEPER UNDERSTANDING OF THEIR UNIQUE NEEDS. 
